

Minutes of the regular meeting of the Ransom District Library Board of Trustees – June 15, 2010

Meeting was called to order by President Asselmeier at 7:00 p.m.

President Asselmeier welcomed new board member Lee Klade, who was appointed by the Gun Plain Twp. Board to replace Pat Miles.

Special Agenda Item: Public Hearing to set levy at .9176 mills. No public attended.

Motion to approve the minutes of April 20, 2010 as written, Klein/Prentice carried.

Financial Report: Money has been transferred to Edward Jones to invest and bring the PNC accounts within the FDIC limits. Health Insurance payments were made to employees eligible for benefits. The first half of the State Aid payment of \$2500.00 was received as well as \$16,000.00 in delinquent taxes from Allegan County.

President's Report – No Report

Director's Report : Bubble Man was a big hit with approx. 150 people attending. Upcoming is a sand castle class with Mr. Wakefield.

Financial

- \$75,000 check is going to Edward Jones on 6/15/2010 to get our total PNC balance under \$250,000 and maintain FDIC insurance.
- The health insurance line item is now showing over budget due to paying \$1298 for our first month's premium to Priority, plus \$4800 to fund the HSA's.
- We just received our first 50% state aid payment, approximately \$2500, that is not yet reflected in the financial statements.

Programs

- The Summer Reading program has kicked off! This year's theme, "Make a Splash", features lots of fun water and beach-themed activities, including a class in sandcastle building, taught by master sand sculptor Charles Wakefield.
- The first Memorial Day book sale was a huge success, profiting \$807 in a five-hour sale. We also heard a lot of positive feedback from attendees, and of course the set-up and takedown were MUCH easier than being downtown during the festival. We look forward to making this an annual event!

Administrative

- I returned the contract and down payment for strategic planning services to Hartzell-Mika. At this point, the plan is to hold focus groups at the end of August. We will then have two 6-7 hour Saturday sessions to meet with the strategic plan committee, comprised of board members and key community stakeholders. The tentative dates for the Saturday sessions are October 2 and October 30 (specially chosen to not interfere with any major college football games!). Please save these dates! I am in the process of identifying potential attendees for four focus groups: business, "Moms", seniors, and non-users. In addition, Erin will conduct a teen focus group.
